VST Tillers Tractors Limited (VST), India's leading farm equipment manufacturer, today announced their Q4 and Annual Results for the financial year 2022-23.

For full year FY23, VST has achieved a historic milestone Revenue of **Rs 1,006.43** Crores with a healthy growth of 17.8% over FY22. EBIDTA margin stood at **Rs 152.16 Cr**, which is 14.75% on sales. This is despite commodity inflation prices and reduction in other income from the Mark to Market gain on Investments.

For Q4 FY23, revenue stood at **Rs 322.61 crore**, registering strong growth of 47.7% over the same quarter last year. EBITDA for Q4 stood at **Rs 59.78 Crore**, which is 18.23% of Sales.

VST has achieved Highest ever sales of Power Tiller at 38,247 units in FY23 and export of tractors is continuously growing and at 1458 Tractors for FY23.
